- A "letter of recommendation" from the applicant's parish priest confirming good standing in the Orthodox Church must be submitted; •
- All staff applicants are subject to a criminal background check which shall be sent as a link via email where the applicant shall provide the required . information directly to the background check company as soon as possible (each background check shall remain valid for 3 years);
- All persons whose applications are accepted must bring a current Drivers License/Photo ID to camp to be photocopied and kept on file by the ROEA;
- All persons whose applications are accepted must complete and submit a health information form that will be provided by the camp administration;
- All persons whose applications are accepted must review and adhere to rules for staff members that will be provided, as well as the required child abuse prevention materials (to be provided via email prior to camp session);
- No visitors are allowed on camp grounds without prior approval from the camp administration;
- Pets (dogs, etc) are not allowed on camp grounds unless they have advanced training and are approved in advance by the camp administration;
- The camp administration reserves the right to require any staff member to leave the camp at any time.

I agree to hold free from harm and responsibility the Romanian Orthodox Episcopate of America (ROEA), Camp Vatra and any individuals or organizations associated with these two entities in the case of any personal harm or injuries that I may incur while working at Camp Vatra.
